Conflict of interest exists when an author (or the author's institution), reviewer, or editor has financial or personal relationships that inappropriately influence (bias) his or her actions (such relationships are also known as dual commitments, competing interests, or competing loyalties).

These relationships may vary from those with negligible potential to those with great potential to influence judgment, and not all relationships represent true conflicts of interest. The potential for conflict of interest can exist whether or not an individual believes that the relationship affects his or her scientific judgment. Financial relationships (such as employment, consultancies, stock ownership, honoraria, and paid expert testimony) are the most easily identifiable conflicts of interest and the most likely to undermine the credibility of the journal, the reviewers, and the authors.

However, conflicts can occur for other reasons, such as personal relationships, academic competition, and intellectual passion. Please note that the appearance of a conflict also constitutes a conflict of interest.

## Conflicts of interest for the Editor-in-Chief

The Editor-in-Chief has full authority and responsibility over the entire editorial content of the journal and the timing of publication of that content, including published content, editorial decisions, and ethical standards (fair play, confidentiality, disclosure of potential conflict of interests, and objectivity). The EiC personally handles submissions from Associate Editors and Board members. Editors are blocked from accessing their own submissions when they are acting as Authors.

## **Conflicts of Interest for Editors**

Editors should recuse themselves from considering manuscripts in which they have conflicts of interest resulting from competitive, collaborative, financial, or other relationships/connections with any of the authors, companies, or institutions connected to the papers.

## Conflicts of interest for authors

Authors are fully responsible for recognizing and disclosing financial or other conflicts of interest that might bias their work or could inappropriately influence his/her judgment.

Upon submission, the author(s) are required to declare any conflicts of interest, funding, employment, leadership, or honoraria. This information must also be included within the manuscript before the References section. A lack of conflict of interest must also be declared unequivocally. All sources of financial support for the work should be disclosed (including the grant number or other reference number, if any).

NOTE: The ICMJE has developed a <u>uniform disclosure form</u> for use by ICMJE member journals. Precision Nanomedicine accepts disclosures generated by this form.

## Authors' statement

Before finalizing the publication, authors must sign a statement that all authors have read, provided comments, and approved the final version of the manuscript. They certify that the authors listed meet all criteria of Publication Ethics and roles and responsibilities of authors as described in the International Committee of Medical Journal Editors for Authors, and they take full responsibility for the content of the manuscript. Separate PDF documents from authors are acceptable, but all signatures must be original.
